4b (Code: ) (Expenses \$ 1,161,065 including grants of \$ ) (Revenue \$ 4,120 ) Adult Education: This program provides comprehensive courses for participants above 18 years old to gain the skills and education necessary to achieve self-sufficiency and a higher standard of living. Courses offered include English as a Second Language (Levels I-IV), Adult Basic Education, General Equivalency Diploma (GED), Computer Skills Training and Workforce Training. Offered at two locations (CFC's main office and a leased facility in Southwest Houston), CFC utilizes the Texas Curriculum, which was designed by the Texas Educational Agency and promoted by the National Institute for Literacy. Classes are taught by degreed instructors who use a holistic approach to immerse students in the English language. The curriculum is coupled with a functional, real-life approach so that students can quickly learn new skills and practice their new found knowledge at home, at work, and in the community.
