Family Support Services: These provide comprehensive services within the agency's continuum of care, including: information dissemination, intake and referral services, food pantry, and health screenings and immunizations.

Youth Services: This program provides comprehensive support services and education to teenagers, including substance abuse prevention education, and summer programs and count-down to college programs.

Adult Education: This program provides comprehensive courses for participants above 18 years old to gain the skills and education necessary to achieve self-sufficiency and a higher standard of living. Courses offered include English as a Second Language (Levels I-IV), Adult Basic Education, General Equivalency Diploma (GED), Computer Skills Training and Workforce Training. Offered at two locations (CFC's main office and a leased facility in Southwest Houston), CFC utilizes the Texas Curriculum, which was designed by the Texas Educational Agency and promoted by the National Institute for Literacy. Classes are taught by degreed instructors who use a holistic approach to immerse students in the English language. The curriculum is coupled with a functional, real-life approach so that students can quickly learn new skills and practice their new found knowledge at home, at work, and in the community.
